- 8. Income tax registration and clearance certificate for the last 3 years and NTN of the firm/contractor.
- 9. Pre-qualification certificate / letter with Government and Private Entities.
- 10. Managerial capability of the firm.
- 11. Affidavit / Certificate on stamp paper of Rs. 100-/ that the firm was not black listed by any Government / Semi Government / Private body.
- 12. Any other supporting documents which may help for pre-qualification of firm.

Only shortlisted firms shall be entitled to participate in the subsequent consultant selection proceedings. The Executing agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposal, but shall not be required to justify those grounds.
