Applications are invited from suitable disabled candidates along with C.V (on printed application from available from the Establishment Office of this University) having domicile of Punjab with one attested copy of all educational certificates, CNIC, domicile certificate, on contract basis for 03 years (extendable subject to good performance) for different categories under the following terms and conditions:-

1. Recruitment shall be made according to the prevailing contract policy for tenure of three years, extendable subject to good performance.
2. Both male/female disabled applicants must be domiciled of Punjab Province.
3. The applicants are also required to submit a draft pay order of RS. 1000/- (for BS-18) RS. 800/- (for BS-17) RS. 500/- for BS-16) RS. 500/- (for BS -12 , 07 & 01) in fever of "Treasurer" Government. College Women University, Sialkot along with other documents.
3. 10-years age of relaxation in upper age limit for disabled persons.
4. The posts are non-transferable.
5. Short-listed candidates will be issued call letters for test / interview.
6. No application will be entertained after due date.
7. Disabled person already in Govt. & Semi Govt. Services should apply through their department along with NOC.
8. The eligible disabled short listed candidates must bring original documents (certificates, domicile, computerized national identity card, etc.) On the dates of interview.
9. The selection will be made on merit amongst disabled.
10. Age, Qualifications and experience as per Govt. Rules / Policy.
11. Disabled persons shall attach certificate of invalidity issued by the District Assessment Board. Only those disabled person shall be eligible who have been declared by Assessment Board to be disabled but fit for the job applied.
12. No TA/DA will be allowed.
13. Incomplete application will not be entertained in any case.
