### TENDER NOTICE

GC Women University Sialkot invites the tender for the following works on the basis of **Single Stage Single Envelope** from well reputed firms Registered with PEC in the category C-4 or above code CE-10, FBR and Punjab Revenue Authority (PRA).

All the contractors who are registered with Pakistan Engineering Council (PEC) in category C-4 or above can participate in open E-Tendering System. Procurement procedure strictly be adopted in accordance with PPRA rules 2014 (with up to date amendments). Contractors can participate in E-tendering after fulfilling the following terms and conditions:

- Contractors may register their firms on website <https://punjab.eprocure.gov.pk> by submitting their requisite information.
- After registration on E-Tendering website <https://punjab.eprocure.gov.pk> contractors of eligible categories may participate in E-Tendering.
- Contractors / bidders have to upload scanned copies of Call Deposit Receipt (CDR) of an amount of **Rs. 2,899,848/-** i.e. @ 2% of the estimated cost from any schedule bank in favor of **Treasurer Government College Women University Sialkot**. Original CDR must be submitted to the Tender Opening Committee on Tender opening date i.e. **16-06-2025** not later than 02:00 PM.
- Contractors have to quote their rates online against each item of BOQ up to **16-06-2025 before 01:30 PM** after receiving BOQ of the scheme available at website. The rates quoted online by the contractors will be downloaded from website and will be announced on same date at **02:00 PM** in the presence of participating firms / contractors (who opts to be present) and tender opening Civil Works Committee in the Committee room of GC Women University Sialkot.
- All the contractors participating in E-Tendering will be bound to submit their original CDR's with company Letter Heads, FBR and PRA certificates and Valid PEC certificate to the Tender Opening Committee on **16-06-2025** but not later than 02:00 PM. In case of failure, the contractor will be declared as Disqualified from the tender process in the presence of Tender Opening Committee. Further his case will be recommended to Higher Authority for taking strict Legal action against the firm.
- In case of False information, Fake CDR, the contractor will be liable to disqualify as per PPRA rules and will not be eligible to participate in upcoming tenders of University. Further his case will also be forwarded to PEC and PPRA for initiation of strict Legal Action.
- Tender Opening Committee may reject all bids or proposals at any time prior to the acceptance of Bid or proposal.
- The procuring agency shall, upon request, communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.
- The contractor will have to quote the Item rates in uploaded BOQ not the percentage rates. In case any contractor quotes Percentage Rates, the same will be considered as "Non-responsive" and not to be included in the competition for determination of Lowest Evaluated Bidder vide PPRA Circular dated 11-10-2024.
